

**NOTICE FOR PRIORITY-III CANDIDATES: SPECIAL STRAY  
VACANCY ROUND OF PG COUNSELLING 2023 (MD/MS/DNB)  
FOR ADMISSION IN AFMS INSTITUTIONS THROUGH  
NEET PG-2023**

1. The Special Stray Vacancy Round of PG Counselling 2023 for MD/MS/DNB courses in AFMS institutions for Priority-III candidates will be conducted by 02:30 PM on 22 Nov 2023 on an online mode. Candidates who are not holding any seat either in All India Quota, State Quota or in AFMS Institutions are eligible to participate in Special Stray Vacancy Round of AFMS PG Counselling. However, candidates who did not join their seats allotted through MCC/AFMS Round-3 onwards are 'Not Eligible' to participate.

2. Priority-III candidates desirous of attending Special Stray Vacancy Round of AFMS PG counselling 2023 are required to forward a scanned copy of following documents by e-mail to [neetpge@gmail.com](mailto:neetpge@gmail.com) with the subject '**NEET PG ROLL NO XYZ : PRIORITY-III AFMS SPECIAL STRAY VACANCY ROUND OF PG COUNSELLING-2023**'.
